We have reviewed the accompanying statement of unaudited consolidated financial results ('the Statement') of APIS India Limited ('the Holding Company') and its subsidiaries (the Holding Company and its subsidiaries together referred to as 'the Group') Associate and its Joint Venture, (refer Annexure 1 for the list of subsidiaries, Associate and Joint Venture included in the Statement) for the quarter ended 31st December, 2021, and the consolidated year to date results for the period 01 April, 2021 to 31st December, 2021, being submitted by the Holding Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), including relevant circulars issued by the SEBI from time to time.

Based on our review conducted and procedures performed as stated in paragraph 3 above and upon consideration of the review reports of the other auditors referred to in paragraph 5 below, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with recognition and measurement principles laid down in Ind AS 34, prescribed under Section 133 of the Act, the SEBI Circular and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in accordance with the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), including the manner in which it is to be disclosed, or that it contains any material misstatement.
- 5. We did not review the interim financial results of two subsidiary included in the Statement, whose financial information reflects total assets of Rs. 746.60 Lakhs as at 31st December, 2021, and total revenues of Rs. Nil and Rs. Nil, total net profit/(loss) after tax of Rs. (00.43) Lakhs and Rs. (00.49) Lakhs, total comprehensive income of Rs. Nil and Rs. Nil, for the quarter and nine months period ended on 31st December, 2021, respectively, as considered in the Statement. These interim financial results have been reviewed by other auditor whose review report has been furnished to us by the management, and our conclusion in so far as it relates to the amounts and disclosures included in respect of these subsidiaries is based solely on the review report of such other auditors and the procedures performed by us as stated in paragraph 3 above. Our conclusion is not modified in respect of these matters.
- 6. The Statement also includes the Group's share of net profit after tax of Rs. 119.60 Lakhs and Rs. 125.30 Lakhs, and Group's share of total comprehensive income of Rs. 1426.20 Lakhs and Rs. 3150.096 Lakhs for the quarter and nine months period ended on 31st December, 2021 respectively, in respect of an associate and joint venture, based on their interim financial results, which have not been reviewed by their auditors, and have been furnished to us by the Holding Company's management. Our conclusion on the Statement, and our report in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), read with SEBI Circular, in so far as it relates to the aforesaid joint venture, are based solely on such unreviewed interim financial results. According to the information and explanations given to us by

the management, these interim financial results are not material to the Group. Our conclusion is not modified in respect of this matter




